## Funeral for Bill Copps, who died Monday, is Saturday in the Vancouver Funeral Chapel

**Bill Copps**, co-owner of Bill Copps Inc., downtown Vancouver's last remaining new car dealership, died suddenly Monday after being taken to Southwest Washington Medical Center. He was 76.

Mr. Copps's only survivor is his wife of 53 years, **Eleanor**, whose father Austin McCoy founded the dealership in 1917.

The dealership at 901 C Street sells Cadillac, Pontiac, GMC and Suzuki vehicles.

Mr. Copps, a Vancouver native and a graduate of Vancouver High School, received a mechanical engineering degree from the University of Washington.

He was a member of the Episcopal Church, Vancouver Rotary, Royal Oaks Country Club, Elks Lodge, and the Smith-Reynolds Post of the American Legion.

The funeral is at 11 a.m. Saturday, Jan. 25, in the Vancouver Funeral Chapel.

## County unemployment rate down in December

Clark County's seasonally unadjusted unemployment rate fell to 7.9 percent in December, down 4 points from 8.3 percent in November, reports the state Employment Security Department.

The state's seasonally unadjusted rate rose one-tenth of a percent to 6.8 percent in December. The national rate for December was 6 percent.

Of the county's labor force of 186,900 persons, 14,700 were without jobs, according to the state report.
