County extends growth plan comment period

Clark County will accept public comment through October 2 on a Draft Environmental Impact Statement (DEIS) that examines alternative locations to meet the projected need for homes and jobs through 2024. Input on the draft will help the county prepare a "preferred alternative" for closer examination in a Final Environmental Impact Statement and public hearings this fall.

The Board of Commissioners will prepare the preferred alternative in a work session on October 10 from 1 to 4 p.m. in the Clark County Public Service Center, sixth-floor hearing room, 1300 Franklin Street, Vancouver. This work session, previously scheduled for October 3, was delayed to allow more time for public comment. This is the next step in the process for the Board to consider changes to urban growth boundaries adopted in 2004.
