

## Hearing on business license surcharge postponed

A public hearing on Vancouver's proposed business license surcharge, scheduled for Monday, Feb. 27, has been postponed. The city council has asked for more time to review and analyze the impacts of the proposed ordinance which would establish a business license surcharge that would be paid in addition to the current applicable business license fees.

Surcharge revenues would be used for new capacity transportation projects. The public hearing will be rescheduled within the next 30 to 60 days, cit officials said.

Phillips added: "With our clients in primary industry sectors, selling goods and services outside the region, the overall direct and induced wage impact exceeds \$882 million. Our clients are making a huge difference in the economy and quality of life of Clark County citizens.

"CREDC clients are industrial companies that CREDC has recruited to the county or helped stay in the county. A recent survey showed that 65 percent of those clients remain in business in the county today."
